

THE SPOILS OF WAR CONSIGNMENT AGREEMENT

_____, hereinafter referred to as "Consignor", by his/her signature on this Agreement, agrees to the following terms and conditions of THE SPOILS OF WAR, hereinafter referred to as "The Spoils of War":

1. The Spoils of War shall receive a commission of twenty percent (20%) of the sales price of all consigned items.
2. Consignor will not receive payment for any consigned item until such item is sold. Payments will be mailed by The Spoils of War to Consignor on the 5th day of the month following sale of an item, provided The Spoils of War has received the funds and a sufficient period of time has expired to allow a reasonable inspection period by the purchaser of the consigned item. Consignor will be notified by email when a consigned item is sold.
3. Consignor will pay all shipping charges to send consignment item(s) to The Spoils of War.
4. The Spoils of War shall be entitled to retain and list each consigned item on The Spoils of War website for a period of 90 days from receipt thereof and no consigned item will be returned to Consignor during such 90-day period.
5. Any consigned item which has not sold after a 90-day listing on the website may be returned to Consignor at The Spoils of War's option and at The Spoils of War's expense.
6. Shipments received without a written descriptive list of the contents, the amount which Consignor wants for each item, and this Agreement signed by Consignor will be returned.
7. Consignor's signature on this Agreement is a warranty by Consignor that to the best of his or her knowledge, information and belief, the enclosed items are genuine and authentic military artifacts and are not reproductions, unless expressly indicated as such.
8. The Spoils of War has the right to return to Consignor any item which the employees of The Spoils of War determine or believe to be a reproduction, or which has been altered or faked in any manner; cleaning, normal repairs or restoration being excepted.
9. Reproduction items will be listed as such in the item description.
10. The Spoils of War has the right to refuse to list any item which its employees deem to be inappropriate or undesirable for any reason.
11. No item is to be shipped by Consignor in a glass enclosure, and any such item so shipped, including items framed under glass, will not be accepted unless prior authorization is received by Consignor from The Spoils of War.
12. No firearms, flares, explosives, live pyrotechnics or live primers will be accepted.
13. Inert ordnance will be accepted, but only if disassembled.
14. The Spoils of War makes no guarantee that any consigned item will sell after it is listed on the website.
